What is Needed


- 33,000 square feet
- 2-story or 1-story space
- Seating for community members of all ages
- Meeting spaces (study rooms, meeting rooms, program spaces)
- Collection space
- Staff workspace, including storage
- Separate areas for active and quiet uses (e.g. children's area and quiet reading room)
- 4 acre site ideal for current needs and future expansion potential
